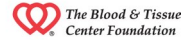

PERSONALLY IDENTIFIABLE INFORMATION CONSENT AND RELEASE FORM

I, the undersigned individual:

1. hereby irrevocably consent, grant and give permission to BioBridge Global, a Texas nonprofit corporation (BBG) and its nonprofit subsidiaries, including the South Texas Blood & Tissue Center, QualTex Laboratories, GenCure and The Blood & Tissue Center Foundation, their successors, assignees and licensees (collectively "BBG Group") the following:

b. all right, title and interest that I may have in all finished pictures, negatives, reproductions, and copies of the original print, and right to give, transfer, exhibit or sell the print in copies or facsimile image for marketing, communications or advertising purposes, and,

c. the use, publication and broadcast by the BBG Group of my name in connection with any image (whether digital, electronic or video), likeness, photographs or other information of or about me.

I agree that any of my PII may be used by the BBG Group for purposes such as locating me, BBG Group publicity or advertising on media such as television, radio, print publications, social media sites, Internet websites and/or BBG Group publications (newsletters, flyers, brochures, educational information or brochures, websites, and other means of communication now or hereafter existing).

3. This consent and release extends to contractors and representatives of the BBG Group who may provide publicity, informational or other services from time to time to any member of the BBG Group. I understand and agree that any of my PII, if used or communicated, may be used by other entities such as media outlets, news organizations, and other third parties outside of and beyond the control of the BBG Group.

b. any proprietary rights I may have to my image and voice (whether digital, electronic or video), likeness, photograph, moving image, audio clip or other information, and

c. any right to inspect or approve finished images, photographs, audio, video, multimedia, recordings, prints, copies, digital or other medium of use containing any of my PII, and

d. each member of the BBG Group and their respective employees, agents, representatives and contractors from any and all claims, actions, and liability for damages, losses, or expenses of any sort which may arise in connection with the use of any of my PII as permitted by this consent and release form.

a. I (and, if applicable, my parent or legal guardian) have read and understood this consent and permission form and understand the significance and meaning of the terms of this consent and release form,

b. I (and, if applicable, my parent or legal guardian) have been given full opportunity to ask questions and discuss the implications of this consent and release,

c. I (and, if applicable, my parent or legal guardian) (i) give consent and sign this form voluntarily of my own free will without duress and my decision is not based upon representations or advice by representatives of the BBG Group,

d. I (or, if applicable, my parent or legal guardian) have legal capacity to sign this consent and release form.
